**BAA STANSTED
WORKING TO REDUCE NOISE LEVELS**



Stansted is well aware of the impact of aircraft noise on the community. Many of the controls relating to aircraft noise and keeping to designated routes are set for the airport by the Department for Transport with whom BAA works closely to monitor aircraft noise and track keeping, review performance and implement ways to improve the noise environment.

DEPARTING AIRCRAFT

All departing aircraft are monitored for noise and track keeping by Stansted's Flight Evaluation Unit. Owners of aircraft which exceed departure noise limits are levied with surcharges as are aircraft which fail to adhere to the designated routes for no valid reason. Noisier aircraft are discouraged by applying higher landing charges.

CONTINUOUS DESCENT APPROACH (CDA)

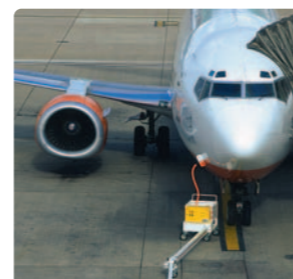
When aircraft first arrive in the UK they are directed to holding areas called stacks. There is one stack to the north-east of the airport and one to the north-west. From approx. 6000ft the aircraft begins continuous descent to 3000ft



where it is established on the Instrument Landing System (ILS). This procedure reduces noise heard on the ground as aircraft use less engine power than if they fly continuously at the same height. CDA currently applies to aircraft landing from the north due to airspace constraints to the south of Stansted's runway.

GROUND NOISE

BAA imposes a general duty on all aircraft operators to minimise ground noise whenever possible. One way in which BAA has contributed to the lowering of ground noise is the provision of an alternative fixed electrical ground power source. This power source, enabling an aircraft to be prepared for flight, is silent and pollution free.



ENGINE GROUND RUNNING

A limited amount of ground running is required as part of routine checks to confirm flight safety or after maintenance procedures. BAA Stansted strictly controls all engine ground running and all requests to run engines require specific approval by Airfield Operations. BAA Stansted has applied for a second pen to reduce noise from aircraft engine testing.

THE OPTIONS

BAA Stansted's scheme is designed to offer choice and flexibility to meet a wide range of needs and you can choose one of the following options

- Free secondary glazing to fit existing windows
- OR a 50% contribution to standard double glazed PVC-U replacement windows
- OR a 50% contribution to high specification double glazed PVC-U replacement windows, specifically designed to reduce noise levels
- OR a combination of these options

In addition you will receive

- FREE ventilation with each option
- FREE loft insulation where none currently exists

You will be eligible to participate in the new scheme even if you have benefited from a previous programme.

The only areas of the home not included in the scheme are the hall, landing and conservatory.

THE WAY FORWARD

- Register your interest by completing the application form and returning it to us within two months so that we can proceed quickly
- Our contractor's surveyor will then make an appointment to visit you at home to discuss your individual requirements
- BAA will arrange to carry out the work
